

In order to provide accurate pricing and ensure compliance with waste disposal regulations, we require accurate listings of all hazardous waste items and materials. This should include the number of containers by size and accurate descriptions, MSDS (where required).

Commonly used to dilute paint and clean products, these waste types must be treated as hazardous waste. We can collect the following materials:



other waste types.

### **Empty Contaminated Containers**

We collect and dispose of contaminated waste packaging safely from businesses across the UK. These empty containers should contain less than 1% residue. Our team can collect both small and large quantities of contaminated waste, and may require an MSDS with details regarding the previous contents.



### **Chemical Waste Disposal**

We provide a chemical waste collection service for businesses and organisations all over the UK. This may include laboratory waste, out of date chemicals, manufacturing waste and much more. Both liquid chemicals and contaminated packaging will be dealt with safely and compliantly. MSDS may be required to provide detailed information regarding the chemical types.

To support safe storage and handling, we obtain or verify the correct Material Safety Data Sheets (MSDS) for each chemical.


### **Battery Waste Recycling**

Our hazardous waste and WEEE team collects a range of battery types for recycling. We also provide vermiculite for packaging lithium batteries, acting as a fire-extinguishing agent and a thermal insulator. With an ADR-verified logistics team, we ensure safe, compliant disposal for a range of battery materials:



### **Electronic Waste Recycling**

We collect and recycle all types of electrical waste which are taken to our depot which operates under a T11 exemption from The Environment Agency. Our team can also collect a mixed load of various WEEE in one collection.



#### **Fluorescent Tubes**

This electrical waste contains hazardous materials and must be dealt with safely. Our waste services includes:


#### Solar Panels


### **Replacement Drums & Packaging**
